1. Login Credentials
2. MISMO 3.4
3. Valid Credit Re-Issue Credentials
4. Intended Program Name
5. Required Docs **see below**

Documents Requirements

Documents needed for all programs

1. Sales contract on purchase loans
2. LOE on Investment Cashout loans
3. Asset Documentation for Reserves/Cash to Close

Empower Ease - Alt Doc

- P&L
 - Signed and dated by CPA, Independent Licensed Accountant &/or Certified tax preparer
 - Must cover most recent previous 12 months
- 1099
 - For previous Tax Year
- Written VOE
- Asset Depletion/Utilization
 - Provide most recent six (6) months bank/asset statements to be considered

Empower More / Elite: Bank Statement

- Bank Statements (12 or 24 months) – already run through Emporium Analyzer

Empower - Full Doc

- Pay Stubs and W-2's
- Tax Returns (Personal and Business if applicable - Self Employed)
- YTD P&L (Self Employed)

DSCR

- Property Lease Agreement if Applicable

Escrow Is Required When:

- Primary Residence HPML loans
- LTV >/= 80%
- Flood Insurance is required
- Debt Consolidation Refinances
